**Application No: 08/01884/FUL & 08/01885/LBC.** Erection of timber framed shelter and formation of new external door opening. **Location:** The Cross Keys, The Street, White Notley. The Council had no objections to the new door but object to the shelter for the same reasons as before (July 08/61).

**Application No: 08/01920/FUL.** Erection of single storey rear extension. **Location:** 9 The Street, White Notley. No objections.
