# 09/95. TRAFFIC SPEED REPORT.

Representatives from ECC and the Traffic Police were unable to attend. The traffic police have carried out some enforcement in the area.

The response from ECC is summarised as follows:

- Speed is of concern continued enforcement does work.
- The installation of any form of build-outs would require street lighting and additional signs.
- Some measures at each end of White Notley have been ordered in the form of 4.2 metre high roundels adjacent to the 30mph signs. Additionally further roundels have been ordered to be installed on

Church Hill adjacent to the 30 mph repeaters (which will be enlarged with yellow backing boards) near to Vicarage Road.

- In addition to enforcement, the installation of roundels adjacent to the 30mph signs at Faulkbourne may bring the speed limit to the attention of motorists.
- There will unfortunately always be those motorists that do not heed the speed limit or prevailing conditions.

It was agreed to ask ECC about the provision of a zebra crossing as a traffic calming measure by the Cross Keys. The idea of a mini roundabout at the bottom of Vicarage Avenue was raised again although this has been refused by ECC previously.
